Reports

This matter has been addressed in previous newsletters but for clarification, please note the following:

All reports go through a management process. Reports will be handed out to the learners on 1 April 2015 at 10:45. Staff will hand any remaining reports back to office at 11:00 for collection by parents.

Should you wish for a friend or family member to collect your child's report between 11:00 and 11:30, you need to write a permission letter to the office asking us to release the report to that person. This letter needs to reach us before 10:45 on 1 April 2015.

At 11:30, all uncollected reports will be locked in the vault till the first school day of the second term. We will gladly forward reports, but only to parents who provide us with a prepaid and self addressed envelope.

We do understand individual circumstances but to prevent any expectations or exceptions we will not deviate from this policy.

Behaviour

Safety officials observed our school over a few days and if this is the message Sunridge is conveying, it's wrong! It saddens me to have to address the following matters.

1. Traffic

It has been brought to our attention that some parents tend to ignore basic road safety measures around our school when dropping off learners or picking them up. This is unacceptable and because my staff have been verbally abused when talking to these parents I have no choice other than to request the traffic department monitor the traffic.

The first fine was issued last week and more will follow. We cannot take responsibility and will report this to authorities.

2. Left after school hours

We find more and more learners are left at school well after normal school hours. Authorities have advised us to file a case of negligence against the parents should this happen regularly. We will now monitor this frequently.

3. School building

We often find parents place themselves above our rules and regulations. They enter our building as they please with a variety of excuses. A parent without a visiting card will find himself/herself on the wrong side of the law on entering our building. This is a friendly and final warning.

4. School grounds

We usually opened the gates 30 minutes before the end of the day for children to be collected. This has become another nightmare with parents entering the building and even classes. We will now only open the gates 5 to 10 minutes before the end of the school day.

5. Sport

Parents waiting or attending sport practices after school hours misuse this privilege by entering our building. We would like to remind you that without an official visitors card you are not allowed access into the buildings.

6. Aftercare

There are no special privileges for any aftercare ladies. Although they are allowed, for convenience and safety purposes, to fetch learners on our grounds, they are to adhere to the same rules and regulations. Their access to the building is a privilege and not a right.

7. Outside activities

The mere fact that some activities are presented on our premises or in our building does not grant any parent the right to access our building. Permission is for the child to participate in the activity.

Please consult the Regulations for Safety Measures at Public Schools as promulgated by Government Notice 1040 and as amended by Government Notice 1128.

Geagte Ouers

Rapporte

Hierdie aangeleentheid is reeds in vorige nuusbriewe aangespreek, maar die volgende word duidelikheidshalwe genoem:

Alle rapporte gaan deur 'n bestuursproses. Rapporte word slegs op 1 April 2015 om 10:45 aan leerders oorhandig. Daarna sal personeel dit om 11:00 kantoor toe bring om deur ouers afgehaal te word.

Indien u 'n vriend of familielid wil stuur om u kind se rapport tussen 11.00 en 11.30 af te haal, moet u 'n toestemmingsbrief aan die kantoor rig en versoek dat ons die rapport aan daardie persoon oorhandig. Sodanige brief moet ons voor 10:45 op 1 April 2015 bereik.

Alle onafgehaalde rapporte sal om 11:30 in die kluis toegesluit word, tot die eerste dag van die tweede kwartaal. Ons pos met graagte rapporte aan ouers wat aan ons 'n voorafbetaalde, geadresseerde koevert stuur.

Ons het begrip vir individuele omstandighede, maar ten einde enige verwagtinge of uitsonderings te voorkom, kan ons nie van hierdie beleid afwyk nie.

Gedrag

Dit is vir my 'n hartseer dag om die volgende onder u aandag te bring, ná 'n besoek deur veiligheidheidsbeamptes. Hulle het vir 'n paar dae by ons skool observasie gedoen en as dit die boodskap is wat Sunridge uitstuur, is dit verkeerd!

1. Verkeer

Dit is onder ons aandag gebring dat sommige ouers geneig is om die basiese padveiligheidsmaatreëls te ignoreer wanneer hulle kinders af- of oplaai. Dit is onaanvaarbaar en aangesien my personeel deur hierdie ouers verbaal beledig word, is ek verplig om die verkeersdepartement te vra om polisiëring te doen.

Die eerste boete is verlede week uitgereik en meer sal volg. Ons kan nie die verantwoordelikheid aanvaar nie en sal dit aan die owerhede rapporteer.

2. Laat by die skool gehaal?

Ons ervaar dat meer en meer leerders lank ná gewone skoolure by die skool gelaat word. Die owerhede het ons aangeraai om 'n saak van nalatigheid teen hierdie ouers aanhangig te maak indien dit gereeld gebeur. Ons sal dit voortaan gereeld monitor.

3. Skoolgeboue

Ons ervaar dat ouers hulle nie aan reëls en regulasies steur nie. Hulle betree ons geboue net wanneer hulle wil met 'n magdom verskonings. Ouers wat in die skoolgebou aangetref word sonder 'n besoekerskaartjie sal hulleself aan die verkeerde kant van die wet bevind as hulle ons skoolgeboue betree. Dit is 'n vriendelike en finale waarskuwing.

4. Skoolterrein

Ons het gewoonlik ons hekke 30 minute voor die einde van die dag oopgesluit sodat kinders gehaal kan word. Dit het weer eens in 'n nagmerrie ontaard met ouers wat die geboue en selfs die klasse binnekom. Voortaan sal die hekke 5 tot 10 minute voor die einde van die skooldag oopgesluit word.

5. Sport

Ouers wat wag of sportoefeninge ná skoolure bywoon, misbruik hierdie voorreg deur ons geboue binne te kom. U word nie in die geboue toegelaat sonder 'n besoekerskaartjie nie.

6. Nasorg

Geen spesiale voorregte geld vir nasorgdames nie. Hoewel hulle gerieflikheidshalwe en vir veiligheidsdoeleindes op ons skoolterrein toegelaat word, is dit slegs 'n voorreg en nie 'n reg nie.

7. Buiteskool-aktiwiteite

Die blote feit dat sommige aktiwiteite op ons terrein of in ons geboue plaasvind, gee nie aan ouers die reg om die geboue binne te gaan nie. Daar is slegs toestemming verleen vir die kind om aan die aktiwiteit deel te neem.

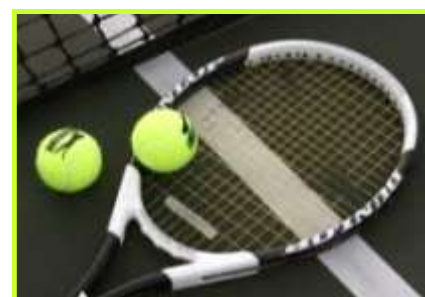
