School Uniform

Please do not buy any new school uniform. The Grade 7's have worn civvies every day for 4 weeks and the question of wearing school clothes for at least one day was made. The decision to make Monday a school uniform day may have been interpreted incorrectly. We apologize for that.

It is not compulsory and it is only to support children who have school uniform which can be used and which will ease the pressure on the wearing of civvies. It is, however, your choice and your child may wear school uniform or civvies every day if they wish to do so.

They may wear what they like as long as it is appropriate and feasible. No open shoes, sandals, slip slops or head gear may be worn. Children may not enter the premises with a hoody on. Balaclavas, buffs, etc. are not masks. You must have a mask on. We recommend that each child bring a face shield as they sometimes battle to breathe with a mask on.

As educators it is our task to educate. We follow instructions and guidance from the Department of Education. It was very clear, we needed to open up schools for education, the time frames were set and we complied with what was given to us. A low risk factor for learners was supported by the various stakeholders. We worked very hard to comply for the opening of our school. We face our shortcomings head on and as staff we want to do what is best for our learners.

We focused on the preparation of our facilities and were assured of support and guidance from the Department. With this in mind all staff worked as a team to ensure the orientation for Grade 1 - 6 could be done without any major problems. This was hands-on for all staff and we can report that we are ready for Monday 6 July 2020.

Please note that we will not have the same number of staff outside to open doors and wave you into 'Drop off Zones'. Please read the part on **Using a "Drop off Zone"** carefully and note that by using it correctly you will be part of the solution and not the problem.

Using a "Drop off Zone"

Created for the safety of our learners and to ensure a safe but quick drop off - it is something new and unknown and something we need to get used to. Again, it is about attitude in using it respectfully and being considerate of other drivers.

Arriving at the allocated "Drop off Zone" please reduce speed, put on your left indicator and enter the "Drop off Zone". Drive as far into the zone as possible and let your child get out of the vehicle, on the left hand side, as quickly as possible. Your child moves to the dedicated walk way or pavement and immediately continues to walk to the entrance. You as the driver immediately leave the "Drop off Zone", put your right indicator on, check the traffic from the right before entering the road and off you go.

You always drop your child off inside the "Drop off Zone", please be aware of other vehicles inside the zone and by watching them you might wait for one to leave enabling you to drive forward for the drop off and allowing the next vehicle to enter behind you.

You never enter a "Drop off Zone" if you are not intending to use it: please reduce speed, and drive past carefully so as to allow the vehicles using it to enter and exit safely.

This will take time to practise and to understand. Only your child may get out of the vehicle, you cannot park inside, at the entrance or exit of the "Drop off Zone". This can be practised with your child and the better we become the safer it becomes.

Not attending school

A few parents have failed to comply and we kindly request that you provide us with the required documentation on or before Friday, 3 July 2020. As from Monday, 6 July 2020 school attendance for learners is compulsory, parents who have failed to submit the documentation (**Application for Exemption from school Attendance**) will run the risk that their child might be removed from our register.

Parents who applied for Exemption can continue with distance education while the school will provide the necessary work and support.

The Future: Reality

With all the above in mind we still need to keep the critical aspect of our learners' safety in mind, this must however include the safety of our teachers. With the current "spike" in positive COVID-19 infections we will also have to face closure in the future as a reality.

A detailed safety procedure which we will follow is being drawn up should and when we need to face the reality.

Should it be necessary to close the school for decontamination and to send learners and teachers home we will communicate it via SMS to all parents. It is also a reality that we will also re-open and try again. We understand that this will cause inconvenience and cause more challenges for parents.

It will also be a huge challenge for us and again we will do our utmost best to manage these challenges. It is not going to be plain sailing and we are already facing challenges in this regard - we might even close before we open.

We are aware of parents who have allegedly tested positive but till we are officially informed we cannot take any actions .

or apply any steps. We kindly request parents to inform us as a matter of principle. Thank you to those who have done so, we respect privacy and it will stay confidential.

We will follow protocol and inform parents as needed. We will not reveal names or any detail and information is only needed to apply the appropriate measures

It is not in our hands, we must follow procedures and the safety of our learners and staff is very important. Yes, we are as safe as what can humanly be expected from the school's point of view BUT no guarantees can ever be given. We will deal with it as it happens and I can only request that all parents take special care, follow the safety measures and plan for the possibility that the school might close.

We are aware and respect the request that schools must close until 3 August 2020. This is however not official and we can only deal with what we have. We will open on Monday 6 July 2020 as planned and a detailed schedule for learners on alternative dates will be sent to all parents.

Let us work together and give it our best to re-open Sunridge, should we need to close, so be it. We are already planning and working on our remote teaching and it will be in place again to support as best we can. Our hard copy service will also be up and running. Yes, we plan for a possible closure as we plan for a possible re-opening and yes this might happen more than once. We do not have control over this as the COVID-19 pandemic is not controllable.

We can agree on the fact that neither our parents, staff nor children have been on a holiday during the lockdown - at times we will disagree on matters but in the end we must agree that our parents, children and staff are important and that we all have to make sacrifices under these unknown circumstances. Thank you for being tolerant, positive and supportive.



Geagte Ouers

Skooluniform

Moet asseblief nie enige nuwe skoolklere koop nie. Met Gr 7 wat reeds 4 weke lank civvies skool toe dra, is die besluit geneem om skooluniform vir minstens een dag te dra. Die besluit om Maandag skooluniformdag te maak, is dalk verkeerd vertolk en ons vra nederig om verskoning.

Dit is nie verpligtend nie en die besluit is slegs geneem om kinders te help wat 'n bruikbare skooluniform het en om die las op civvies te verlig. Dit bly egter u keuse en u kind mag skooluniform of civvies elke dag dra indien u dit verkies.

Kinders mag dra wat hulle wil, solank dit gesik en prakties is. Geen oop skoene, sandale, aanglipsandale of hoofbedekking nie. Kinders mag nie 'n kappietop dra met die kappie op nie. Balaklawas, "buffs" ens. is nie maskers nie. Kinders moet maskers dra. Ons beveel aan dat kinders gesigskerms moet saambring, want dit is partykeer moeilik om die masker heeldag te dra.

Die Pad Vorentoe

As opvoeders is dit ons taak om te onderrig. Ons volg opdragte en leiding van die Departement van Onderwys. Die boodskap was duidelik – skole moet heropen vir onderrig, die tydraamwerke is vasgestel en ons moet die reëls nakom. Verskeie belanghebbendes het van 'n lae risikofaktor vir leerlinge getuig. Ons het skouer aan die wiel gesit om aan die vereistes vir heropening te voldoen. Ons moes struikelblokke oorkom en as personeel wil ons net die beste vir ons leerlinge doen.

Ons het op die voorbereiding van ons fasiliteite gefokus en was verseker van die ondersteuning en leiding van die Departement. Met hierdie doelwit in gedagte het alle personeel as 'n span saamgewerk om te verseker dat die oriëntering vir Gr 1 tot 6 seepglad verloop het. Alle personeel het hul deel bygedra en ons is slaggereed vir Maandag 6 Julie 2020.

Neem asseblief kennis dat ons nie dieselfde hoeveelheid personeel aan diens sal hê om deure oop te maak en u by die aflaaipunte te ontvang nie. Lees asseblief die gedeelte **Gebruik van Aflaaipunte** en maak seker dat u dit korrek gebruik en deel word van die oplossing en nie van die probleem nie.

Gebruik van Aflaaipunte

Die aflaaipunte is daar vir die veiligheid van ons leerlinge en om 'n veilige, maar vinnige aflaai te verseker – hierdie is nuut en onbekend en ons sal daaraan gewoond moet raak. Ingesteldheid is die wagwoord en die aflaaipunte moet met respek en bedagsaamheid teenoor ander motorbestuurders hanteer word.

Wanneer u die betrokke aflaaipunt nader, moet u asseblief snelheid verminder, linkerflikkerig aanskakel en by die aflaaipunt indraai. Ry so ver moontlik vorentoe en laat u kind die voertuig so vinnig moontlik aan die linkerkant verlaat. U kind beweg na die betrokke paadjie of spaadjie en stap onmiddellik na die ingang. U skakel die regterflikkerig aan, maak seker dat daar geen aankomende verkeer is nie en verlaat die aflaaisone onmiddellik.

U kind moet altyd binne die aflaaipunt afgelaai word, neem asseblief kennis van ander voertuie by die aflaaipunt, u sal dalk 'n bietjie moet wag voordat u die aflaaisone kan binnery en dan die volgende voertuig toelaat om die aflaaipunt agter u binne te ry.

U moet slegs 'n aflaaipunt binnery indien u dit gaan gebruik. Indien u 'n aflaaipunt wat u nie gaan gebruik nie, nader, moet u asseblief snelheid verminder, versigtig verbyry en die voertuie wat dit wel gebruik, toelaat om dit veilig binne te ry en te verlaat.

Dit sal tyd neem om te oefen en te begryp. Slegs u kind mag die voertuig verlaat, u mag nie by die in- of uitgang van die aflaaipunt parkeer nie. U kan dit met u kind oefen en hoe meer gekonfyt ons word, hoe veiliger sal dit wees.

Nie-bywoning van skool

'n Paar ouers het nie die reëls nagekom nie en ons versoek u vriendelik om die vereiste dokumentasie op of voor Vrydag 3 Julie 2020 in te dien. Vanaf Maandag 6 Julie 2020 is skoolbywoning verpligtend en ouers wat nie die nodige dokumentasie (**Aansoek om Kwytskelding van Skoolbywoning**) ingedien het nie, kan die risiko loop dat hul kinders van ons register verwyn word.

Ouers wat om kwytskelding aansoek gedoen het, kan steeds afstandonderrig doen, terwyl die skool die nodige werk en ondersteuning sal voorsien.

Die Toekoms: Werklikheid

Met verwysing na al die bogenoemde, moet ons steeds op die belangrikste aspek fokus, naamlik ons leerlinge se veiligheid, asook die veiligheid van ons onderwysers. Met die huidige opwaartse spiraal van positiewe COVID 19-gevalle, moet ons ook besef dat die sluiting van die skool in die toekoms 'n realiteit is.

'n Breedvoerige veiligheidsprosedure is in plek geplaas en sal gevolg word wanneer hierdie uitdaging oor ons pad kom.

'n SMS sal aan alle ouers gestuur word indien die skool vir ontsmetting gesluit moet word en leerlinge en onderwysers huis toe gestuur word. Ons sal beslis ook heropen en weer probeer. Ons begryp dat dit ongerief sal veroorsaak en meer struikelblokke op ouers se pad sal plaas.

Dit sal vir ons ook 'n groot uitdaging wees, maar weereens sal ons alles in ons vermoë doen om die struikelblokke te oorkom. Dit sal nie maklik wees nie, daar is reeds uitdagings in hierdie verband en ons kan selfs sluit voordat die skool heropen.

Ons het verneem van ouers wat na bewering positief getoets het, maar ons is nie amptelik in kennis gestel nie en kan daarom geen stappe neem nie. Ouers word vriendelik versoek om ons in kennis te stel. Baie dankie aan diegene wat dit reeds gedoen het, ons respekteer u privaataheid en dit sal vertroulik hanteer word.

Ons sal protokol volg en ouers waar nodig op hoogte bring. Geen name of besonderhede sal bekend gemaak word nie en die inligting word net verlang sodat die nodige maatreëls in plek geplaas kan word.

Dit is buite ons beheer, ons moet prosedure volg en die veiligheid van leerlinge en personeel is uiters belangrik. Ja, ons is so veilig as wat moontlik by 'n skool verwag kan word, MAAR uit die aard van die saak kan niks gewaarborg word nie. Ons sal elke probleem takel wanneer dit oor ons pad kom en ek kan ouers net versoek om baie versigtig te wees, om veiligheidsmaatreëls na te kom en te beplan vir die moontlikheid dat die skool weer kan sluit.

Ons het kennis geneem van en respekteer die versoek dat skole tot 3 Augustus 2020 gesluit moet bly. Dit is egter nie amptelik nie en ons kan slegs werk met wat ons het. Ons heropen op Maandag 6 Julie 2020 soos beplan en 'n breedvoerige program vir leerlinge op alternatiewe dae sal aan ouers gestuur word.

Laat ons saamwerk en ons bes doen om Sunridge te heropen. Indien ons moet sluit, moet ons dit maar aanvaar. Ons werk en beplan reeds aan ons afstandonderrig en dit sal in plek geplaas wees om kinders na die beste van ons vermoë te ondersteun. Ons harde kopie-diens sal ook weer van stapel gestuur word. Ja, ons beplan vir 'n moontlike sluiting en vir 'n moontlike heropening, en ja, dit kan 'n paar keer gebeur. Dit is, net soos die COVID 19-pandemie, buite ons beheer.

Ons kan wel almal saamstem dat ons ouers, personeel en kinders nie gedurende die grendeltyd met vakansie was nie. Ons kan oor ander sake verskil, maar ons moet saamstem dat ons ouers, kinders en personeel belangrik is en dat ons almal opofferings onder hierdie buitengewone omstandighede moet maak. Baie dankie vir u geduld, positiewe ingesteldheid en ondersteuning.


