Waiting Area

Sadly, this is becoming a thorn in the side. This is not an after care facility and is now frequently being misused by learners (parents). We allow for a 15 to 30 minutes default on picking learners up after school or sport as an exception to the rule. We urge parents to comply and ensure proper arrangements are made.

Discipline

With any aspect in relation to discipline we will not entertain rudeness or parents dictating to us about the outcome they want. We do not disclose the remedial steps taken against any learners. Yes, we have suspended learners in the first term of 2023 BUT it has not been hung out for all to see nor did we disclose information in this regard. We do not brand a child: they faced the music, owned up, their parents supported us in the interest of education and they deserve the opportunity to be treated with respect, regardless of the mistake they have made.

We recommend that a child with any issue, complaint or problem must report it to the teacher as soon as possible. This not only helps us to act in time BUT also prevents the issue, complaint, or problem to escalate or be wrongfully communicated. It also prevents emotional issues, misrepresentation and the mole heap becoming a mountain. Interference, demands and stories prevent us from dealing with it properly.

Defusing the issue, complaint or problem is the first step we take, a simple "sorry" or "handshake" to start with is the beginning of the next step for us to investigate properly. Yes, we must investigate as "allegations" need to be proved. We are dealing with problems that are blown out of proportion, stories that change dramatically, unfair accusations that are presented as facts - and in most cases they are stripped of all truth.

Demands and emotional interference from parents prevents us, in many cases, from getting to the truth as quickly as possible. It can take so long to work with the parents, that the children are already playing with each other again before we get to the real truth.

The real BULLY is no longer in Sunridge BUT the ongoing instigators remain a problem. Please allow us the time to investigate and trust that we will deal with it with the evidence we find and within our policy - move on then as we must inevitably move on, forgive, be tolerant and allow children to make mistakes.

The class teacher will investigate, the Grade Head will support and if necessary take over or refer it to a Head of Department should the matter be beyond their capacity. The Head of Department will in most cases be able to deal with the matter but can refer it to a Deputy Principal if needed. These cases get monitored by Management Team Members on different levels as needed and the team allows staff to deal with the matters in Grades and Phases. The Deputy Principals act as resource persons to ensure that, as far as possible, fair procedures are followed.

A matter, already fully investigated, with evidence, can be taken to the Principal for a decision if needed. This is only for very serious cases - the Principal will sometimes support staff who might need guidance if it is not his/her primary responsibility.

The necessary remedial steps (punishment) are put in place against the guilty person, they are not shared with other parties - we then move on as we believe it has been dealt with. We do not publish remedial steps (punishment) nor discuss them with other parents. It is captured on our management system, documented, and then archived. Children are not branded, condemned or punished twice for the same mistake.

As mentioned before all issues, complaints, or problems have three sides. Your side, the other side and the truth! Sadly, as teachers we battle to get to the truth as seldom do the two sides agree and moreover sometimes get influenced by parents. It takes us hours and days to get to the bottom of cases and the one provoking is in most cases the complainant.

It is not our job to please or to be popular BUT to be fair to all concerned.

Reports

Please note that our policy has not changed. Reports are handed out on the last day of the first, second and third terms to learners at school. Should your child be absent you must email the school with a copy of the ID of an adult who will collect the report from the front office between 11:00 and 11:30. You may also send a self-addressed, stamped envelope for us to post it to you.

The teachers will communicate arrangements, as soon as possible, for learners on official tours or school sport.

Wagarea

Ongelukkig word hierdie area nou vinnig 'n doring in die vlees. Dit is nie 'n nasorgfasiliteit nie, maar word dikwels as sodanig deur leerders (ouers) misbruik. As 'n uitsondering op die reël sal ons 15 tot 30 minute ná skool of sport toelaat vir leerders om gehaal te word. Ons versoek ouers om hierdie reël te gehoorsaam en die nodige reëlings te tref.

Dissipline

Wat dissipline aanbetref, sal ons geen onbeskofte gedrag van ouers aangaande die uitkoms wat hulle verwag, aanvaar nie. Ons hang nie enige remediërende stappe teenoor leerders aan die groot klok nie. Ja, ons het in die eerste kwartaal van 2023 leerders geskors, maar dit is nie uitgedaag nie en ons het ook geen inligting in hierdie verband gedeel nie. Ons brandmerk nooit 'n kind nie – hulle neem verantwoordelikheid vir hul optrede, hul ouers ondersteun ons in die belang van onderrig en hulle verdien die geleentheid om met respek behandel te word, ongeag die foute wat hulle begaan het.

Ons stel voor dat enige kind met 'n klagte of probleem dit so spoedig moontlik by die klasonderwyser aanmeld. Dit stel ons in staat om onmiddellik op te tree, maar dit help ook voorkom dat 'n klagte of probleem vererger of verkeerdlik oortel word. Dit voorkom ook emosionele kwessies, wanvoorstellings en 'n molshoop wat in 'n berg ontaard. Inmenging, eise en lang stories rol ook 'n klip in die pad van 'n deeglike ondersoek.

Ons eerste stap is om die kwessie, klagte of probleem te ontloot – 'n eenvoudige "jammer" of "bladskud" is die begin van die volgende stap vir ons om deeglik ondersoek in te stel. Ja, ons moet ondersoek instel, want "aantygings" moet bewys word. Ons kry te doen met probleme wat buite verhouding opgeblaas word, stories wat dramaties verander, onregverdigde beskuldigings wat as feite voorgelê word – en in die meeste gevalle is dit van alle waarheid ontbloot.

Eise en emosionele inmenging van ouers verhoed ons in talle gevalle om so spoedig moontlik by die waarheid uit te kom. Dit neem so lank om met die ouers te werk, dat die kinders lank reeds weer met mekaar speel voordat ons agter die kap van die byl kom.

Die werklike BOELIE is nie meer by Sunridge nie, MAAR die voortdurende opstokers bly 'n probleem. Gee ons asseblief die ruimte om ondersoek in te stel en vertrou ons om die saak binne ons beleid te hanteer, met behulp van die bewyse tot ons beskikking – beweeg dan aan soos ons onvermydelik moet aanbeweeg, vergewe, wees verdraagsaam en laat kinders toe om foute te maak.

Die klasonderwyser sal ondersoek instel, die graadhoof sal ondersteun en oorneem of na die Departementshoof verwys indien dit buite hul vermoë is. Die Departementshoof sal in die meeste gevalle die saak kan beredder, maar kan dit, indien nodig, na 'n Adjunkhoof verwys. Hierdie aangeleenthede word op verskillende vlakke soos nodig in grade en fases deur Bestuurspanlede gemonitor. Die Adjunkhoofde tree as bystandspersone op om te verseker dat aangeleenthede sover moontlik regverdig benader word.

'n Saak wat reeds ten volle ondersoek is, kan met bewyse aan die Skoolhoof voorgelê word indien 'n besluit deur hom geneem moet word. Dit gebeur slegs in uiters ernstige gevalle. Hoewel die Skoolhoof soms hulp kan verleen wanneer personeel leiding nodig het, is dit nie sy eerste verantwoordelikheid nie.

Die nodige remediërende stappe (strafmaatreëls) word teen die skuldige persoon in plek geplaas en dit word nie met ander partye gedeel nie – ons doen wat ons glo gedoen moet word. Ons hang nie remediërende stappe (strafmaatreëls) aan die groot klok nie en dit word nie met ander ouers bespreek nie. Dit word op ons bestuurstelsel vasgelê, gedokumenteer en dan na die argiewe oorgeplaas. Kinders word nie gebrandmerk, veroordeel of twee keer vir dieselfde fout gestraf nie.

Soos voorheen genoem, het alle sake, klagtes en probleme drie kante – u kant, die ander kant en die waarheid! Ongelukkig sukkel ons as onderwysers om agter die kap van die byl te kom, want dit is selde dat die twee kante saamstem en dit word boonop deur die ouers beïnvloed. Dit neem ure en dae om tot die waarheid deur te dring en in die meeste gevalle is dit die klaer wat die sop sout maak.

Ons is nie hier om mense tevrede te stel of om gewild te wees nie, MAAR om regverdig teenoor alle betrokkenes te wees.
