JUNE: Report Policy

Please note that a report is an official document issued within our academic policy.

This is a sensitive but important matter which causes many problems as 2% of our parents do not follow the rules. As Principal, I unlock the safe before 11:00 and issue all reports based on the attendance register of each class teacher.

Since school attendance is compulsory (South African Schools Act) this also applies to the last day of the term. We close at 11:00 for the holidays and reports are only handed to learners in attendance before they go home at 11:00.

Since we also need to comply with the “exception to the rule” policy, the following is allowed: (1) A medical certificate excusing the child - the Principal will issue their report to the SMT and they will decide how the report will be handed to the learner/parent before 11:00 and (2) A school sport or cultural event confirmed by the SMT, will require the Principal to hand over the reports to the relevant teacher who will hand them out after 11:00.

In the case of children who are absent because they are leaving the school - the Principal will confirm with the administrative office that all documents are in place, he will then scan and email the report to the Deputy Principal who will email the report, in a PDF format, to the parent.

The Principal will lock the safe and any reports not issued in accordance with the policy will remain in the safe until the first day of the next term. The Principal will then hand over the reports to the class teachers if the child is at school.

Only at the end of the year do we hand reports over to parents on a specific day and time as arranged.

Social Media

During a conference in Stellenbosch last week we were in contact with people who use research in education, psychology and neuroscience to understand our world. Experts in both the influential world of media and others in the field can clearly see the influence of social media and the huge risk it poses to children's mental health. There are definitely benefits if well controlled BUT cyber-bullying, privacy violation, sexting and many more risks are a reality and parents are basically handing the tools for exposure to their child.

Without any control, proper training, measures, instructions, manuals or risk analysis our children are given a powerful, wonderful but a potentially dangerous tool to use - and they are under 18 years of age!

Children create a world of their own on the platforms available and eventually they will find themselves in dangerous territory. Many are lucky and even though they escape many of these dangers the scars left will be forever imprinted in their young minds - scars you might never see! Their privacy or that of others will be violated and their profiles will become a means of exchange but at what price? Boundaries will be pushed - either theirs or their friends and parents - tension and flirting become a reality with innocent, stupid, impulsive actions following. When it is not funny, practical jokes, comments, photos and other information becomes the proverbial elephant in the room. One crazy idea and your whole life can change!

Dancing School



Geagte Ouers

JUNIE: Rapportbeleid

Neem asseblief kennis dat 'n rapport 'n amptelike dokument is wat binne ons akademiese beleid uitgereik word.

Hierdie is 'n sensitiewe, maar belangrike aangeleentheid wat eindeloze probleme veroorsaak, want 2% van ons ouers volg nie die reëls nie. As Skoolhoof sluit ek die kluis voor 11:00 oop en reik al die rapporte uit, gebaseer op die bywoningsregister van elke klasonderwyser.

Die Skoolhoof sal dan die kluis sluit en alle rapporte wat nie volgens die beleid uitgereik is nie, sal tot die eerste dag van die volgende kwartaal in die kluis bly. Slegs dan sal die Skoolhoof die kluis oopsluit en die rapporte aan die klasonderwyser oorhandig indien die kind by die skool is.

Slegs aan die einde van die jaar word rapporte aan ouers op 'n spesifieke dag en tyd oorhandig.

Sosiale Media

Tydens 'n "konferensie" verlede week in Stellenbosch was ons in aanraking met mense wat navorsing in onderrig, sielkunde en neurowetenskap gebruik om ons wêreld te verstaan.
