#### Critical - Social Media

We have always been of the opinion that we want to educate our children. We have fought hard not to apply disciplinary hearings and the suspension of primary school learners. We have, however, reached the point where we can no longer entertain the behaviour of some learners.

When we attempt to communicate with parents about social media we find that they ignore us and choose to turn a blind eye. This attitude is slowly backfiring and D-day is so close that we can feel it as children (minors) on phones registered using **parent ID's are digging a hole of devastating consequences.**

Parents now reap what they sow as we, at school, are confronted with WhatsApp groups created by children in which they use abusive, sexually based, foul, gender inflammatory and racial orientated language which includes physical threats and comments way beyond what is expected from a child.

Although some learners are only members of the group and do not comment, by reading these comments they are basically endorsing it. This is all happening on your phone Mum and Dad! The phone is in your name!

This endangers the safety and violates the rights of others as this behaviour is now over flowing into the school environment. **This is a friendly request** to all parents to immediately inspect **your phone** which is being used by your child. Deleted chats should raise questions - we are in possession of a vast number of these chats and voice messages which proves our point.

The above matter escalated to physical attacks on a learner, firstly off our premises and now on the school premises. Please take note that we will now enforce the Code of Conduct guidelines for learners as in the South African Schools Act. We have tried our best to get parents to support corrective behaviour in the above matter. This sadly seems to have failed as **some parent's neglect to apply their parental responsibilities and choose to blame the school, teachers and others.**

Parents cannot fight a battle for children nor dictate and demand outcomes or feedback. Parents reporting incidents on behalf of a child run the risk of facts becoming distorted and others falsely accused.

**A child must inform the class/ subject teachers immediately of any incident. We need the child's version and not the parents** opinion and verdict. Incidents reported late or by parents take longer to investigate as inaccurate facts, emotions, threats, etc. must first be eliminated. The risk of an incomplete investigation becomes a reality.

Your child does not have the right to attack another learner verbally or physically. Retaliation is a misconduct. Your child should report any wrongdoing and allow the school to act in due time and within our policy.

Academic time (contact time) is compromised as investigations take up precious teaching time of educators. We will no longer entertain this and will act with the evidence in front of us.

Any form of verbal and physical abuse/attack will require us to send the child home so as to allow us to investigate - parents will be called to fetch their child immediately. Disruptive and poor behaviour in class will also require us to do the same as the right of the other learners will no longer be put at risk.

Although currently only a small percentage of learners are involved, there are signs that it may escalate out of control. This newsletter was difficult for me to write but a reality that must be shared with parents.

These processes are time consuming and you may be required to keep your child at home for up to five school days. **The time to instill respect and discipline is now.**

### Kritiek – Sosiale Media

Ons was nog altyd van mening dat ons ons kinders wil opvoed. Ons probeer ons bes om dissiplinêre verhore en die skorsing van laerskoolleerders te systap. Nou het ons egter die punt bereik waar ons nie die gedrag van sommige leerders kan dul nie.

Wanneer ons met ouers oor sosiale media probeer kommunikeer, word ons geignoreer en daar word anderpad gekyk. Hierdie ingesteldheid gaan wrang vrugte afwerp en die wiele gaan binnekort afval – kinders (minderjariges) wat selfone gebruik wat op hul ouers se ID's geregistreer is, is besig met dinge waarvan hulle nie die gevolge kan voorsien nie.

Ouers pluk nou die vrugte, want hier by die skool het ons te doen met Whatsapp-groepe wat deur kinders geskep is, waar hulle beleidigende, seksueel-gebaseerde, vulgêre, geslagsonwelvoeglike en rasgeoriënteerde taal gebruik, met fisiese dreigemente en kommentaar wat glad nie van 'n kind verwag word nie.

Hoewel sommige leerders slegs lede van die groep is sonder om kommentaar te lewer, lees hulle dit en keur dit dus goed. Mamma en Pappa – dit gebeur op u foon! Die foon is in u naam!

Dit stel ander mense in gevaar en skend hulle regte, want hierdie gedrag spoel nou oor in die skoolomgewing. **Ons rig 'n vriendelike versoek aan alle ouers om onmiddellik u foon** wat deur u kind gebruik word, te inspekteer. Gesprekke wat uitgewis is, moet die rooi liggies laat flikker, want ons is in besit van 'n groot hoeveelheid van hierdie gesprekke en stemboodskappe wat ons punt staaf.

**Bogenoemde aangeleentheid het fisiese aanvalle op 'n leerder tot gevolg gehad** – eers buite die skoolterrein en nou ook op die skoolterrein. Neem asseblief kennis dat ons nou die riglyne vir die gedragskode vir leerders soos in die Suid-Afrikaanse Skolewet sal toepas. Ons het regtig ons bes probeer om ouers te oortuig om regstellende gedrag in bogenoemde saak te ondersteun. Dit was ongelukkig nie suksesvol nie, want sommige ouers kom nie hul verantwoordelikhede as ouers na nie en kies om die skool, onderwysers en ander te blameer.

**Ouers kan nie namens hul kinders baklei nie en kan ook nie die uitkoms of terugvoer voorskryf nie. Owers wat namens 'n kind 'n incident aanmeld, kan oor verdraaide feite beskik en ander mense vals beskuIdig.**

**'n Kind moet enige incident onmiddellik by die klas/vakonderwyser aanmeld.** Ons het die kind se weergawe nodig en nie die ouer se opinie en oordeel nie. Incidente wat laat of deur ouers aangemeld word, neem langer om te ondersoek, want **onakkurate feite, emosies, dreigemente, ens. moet eers uitgeskakel word. Die risiko van 'n onvoltooide ondersoek word 'n realiteit.**

**U kind het nie die reg om 'n ander leerder verbaal of fisies aan te val nie. Vergelding is wangedrag. U kind moet enige oortreding aanmeld en die skool toelaat om tegeleënertyd en binne ons beleid op te tree.**


**Akademiese tyd (kontaktyd) bly in die slag, want 'n ondersoek neem kosbare onderrigtyd van onderwysers in beslag. Ons sal dit nie langer dul nie en sal optree met die bewyse tot ons beskikking.**

Enige vorm van verbale of fisiese misbruik/aanval sal vereis dat ons die kind huis toe stuur sodat ons ondersoek kan instel. Ouers sal versoek word om die kind onmiddellik te kom haal. Ontwrigtende en wangedrag in die klas sal ook van ons vereis om dieselfde stappe te volg, want die regte van ander leerders sal nie langer in gevaar gestel word nie.




## LEARNER ACHIEVEMENTS / LEERDERPRESTASIES
